**1. Presentation by Alan Muse**

1.1 Alan presented an overview of the [RICS ICMS3 system](#) - Optimising environmental sustainability in construction. **Action:** Alan agreed to attend a CLC Domestic RMI meeting. #### **4. ConstructZero**

4.1 Jennifer Schooling asked if Andy could provide a quote in support of the Carbon Reduction Code and also keen about the possibility of it being more recognised in the CZ workstream (Stuart/Andy has since actioned the quote request)

#### **5. MTC**

5.1 SAG talked around how the MTC's positive work could be continued and potential options.

5.2 An acceptance funding is difficult in the current climate but also recognition industry shouldn't be put off and must try. A suggestion was made that CLC may wish to consider (long-term) the potential to have a more direct relationship with some of the bigger spending departments.

#### **6. Co-chair**

6.1 Andy has suggested 3 people to be on the selection panel, one from BEIS and two from the CLC. He is yet to have spoken to all three. Andy reiterated the invitation was open to SAG and Task Force should any individuals wish to apply.

6.2 The introduction of a new co-chair presents an opportunity to review the CLC's future direction, including how the SAG and Task Force operate; and whether the SAG could be better utilised.
